What is Pitch For Your Project?

Pitch For Your Project is a Monmouthshire Housing Grant Scheme where twice a year projects that are passionate about building stronger communities and having a positive impact on Monmouthshire Housing Tenants, are able to apply for a share of £12,000. The project must have an objective to deliver a wide range of benefits to the community such as economic, social, health and wellbeing, educational or cultural.

Who can apply?

You can apply for the opportunity to Pitch to our judges if you are a community group, not for profit group, Health body, charity or school. Your project must first and foremost be of benefit to Monmouthshire Housing Tenants. The projects that we are looking for must help create strong communities, improve services within the community and also increase people's aspirations. If you are unsure if you can apply just call and ask Clare Evans from the Engagement Team.

How and when can your project apply

To apply all you need to do is complete the application form electronically and email it over to **clare.evans@monmouthshirehousing.co.uk** Applications are accepted during the open round stage. If you wish to submit an application out of this time, we will hold your application until it opens and will contact you for your approval for the continuation of your application. Following your application being submitted it is subject to shortlisting by a panel made up of Monmouthshire Housing Association staff, tenants and a previous winner. If your application is successful in making it to the next round you will be invite to 'Pitch for Your Project' in front of our friendly panel of judges. The panel of judges will consist of a Monmouthshire Housing Staff member, a board member, an Independent body and a previous winner.

The Pitch

We are hoping that this round we will be able to hold the Pitch in Person in Monmouthshire Housing Headquarters. This will be a fun and interactive event where not only will you Pitch For Your community project you will get to meet a mixture of other community groups. In the past links that have been made on the Pitch day have led to successful partnership working. If however circumstances change and we are not able to hold the pitch as planned we will convert back to an online Pitch through the platform of Zoom.

Points to consider for your Pitch:

- Pitches must be a minimum of 5 minutes and a maximum of 7 minutes.
- Inform the panel about what your project is
- Explain how the project will benefit MHA tenants and the wider community
- Make it clear what the funding will be used for
- What is it about your project that has the Wow factor
- Our main aim for this project is to strengthen communities - how will your project do that?
- No power point presentations permitted
- Think outside of the box, have fun with your Pitch and make it memorable
- Following your pitch there will be a short question and answer session from the judges
- You will find out on the day if you have been successful in your pitch



What Can Our Project Apply For?

We are very flexible here at Monmouthshire Housing and consider many requests, regardless of how unique they are but we must stress that the project must hold a positive benefit to Monmouthshire Housing Tenants and be working towards strengthening communities.

Here are some examples of what we will fund:

- Equipment or materials
- Tutor costs for community workshops or lessons
- Venue hire to hold community events
- Musical instruments
- To run a community event such as fun days and promotion of physical activities
- To help set up a new group or pilot a project
- Environmental schemes that improve your community
- Production of community newsletters/ podcasts
- Help with becoming a sustainable group
- Costs associated with running projects that promote the creative arts

We will not fund the following:

- Political parties and religious organisations (to pay for religious practices)
- If you are unable to evidence that MHA tenants will benefit
- Applicants who are applying for individual benefit
- Applications for running costs such as utility bills or rent
- Applications that benefit MHA employees solely
- Fundraising events for your organisation or others
- Contingency costs
- Applications for trips and excursions other than in exceptional circumstances this will be at the panel's discretion
- Any costs you incur whilst putting together your application
- Equipment that mainly benefit individuals

Terms & Conditions

- The amount of funding requested on the application is final and cannot be amended after submission
- Each request will be evaluated on the information presented
- Successful applications cannot reapply for further funding for a further two MHA financial years
- Unsuccessful applications can re-apply within the same financial year
- The request will be rated against an agreed scale of suitability, impact and value for money
- Applications must have the intention of working within the County of Monmouthshire
- We will not approve requests that solely benefit individuals and MHA employees. We will also not approve applications from political parties or religious groups, when they are exclusive to one faith communities
- If the grant is awarded, the applicant agrees to take part in any reasonable publicity organised by Monmouthshire Housing e.g. presentation, press release, photos
- If the grant is awarded, the applicant agrees to provide Monmouthshire
- Housing with a Project evaluation form, which includes key feedback, photos and an end of project evaluation report
- There is £12,000 per round available for all groups that attend the event.
- However, the maximum amount of grant funding we can allocate to one group per round is £3,000
- If the money hasn't been spent a year since received, then the group will need to relinquish the money
- Successful applications must have a bank account for any project funding to be paid into. If you do not currently have a bank account for your project please let us know and we will gladly advise yourself and group on the options available to you. MHA is committed to helping all community groups, no matter whether they are large or small. So please speak to us about your requirements.

Successful applications cannot reapply for further funding for a further two MHA financial years
